A webinar will be held on Monday, November 23rd at 1:00 PM ET when previous AAPI political appointees Grace Choi (State), Namrata Mujumdar (Treasury), Chris Chan (SBA), and Yvonne Hsu (HUD) will talk about about their appointee process, what to expect, how to prepare, and where to start.
