## Call for Faculty and Staffers Nationwide to Endorse Stanford Faculty Letter to AG Garland

On September 8, 2021, a group of 177 Stanford University faculty members from more than 40 departments, including 8 Nobel laureates, sent <u>an open letter</u> to U.S. Attorney General Merrick B. Garland, requesting that he terminate the Department of Justice's "China Initiative."

Since then, <u>214 UC Berkeley faculty members</u> and <u>167 Temple University faculty members</u> have endorsed the Stanford letter and sent in their letters respectively.

If you are also concerned about this issue, the Stanford faculty members have created <u>a</u> <u>website named Winds of Freedom</u> to host the open letter and provide background and instructions on actions that you can take to collect signatories from faculty at your institution to either endorse the Stanford letter or send a similar letter.

With support from the organizers of the Stanford letter, APA Justice invites additional faculty members and qualified endorsers\* from universities and educational institutions across the U.S. to endorse the Stanford letter. We plan to close the campaign around November 3, 2021, and then send a letter with a list of endorsers to AG Garland. \* For the purpose of this campaign, a qualified endorser is defined as a person with the current or former rank of professor, associate professor, assistant professor, lecturer, scholar, or administrator, who has a valid and verifiable .edu email address at an accredited university or similar educational institution in the United States. Titles and associations are for identification only; endorsers do not represent the university or institution. Where judgment on the status of an endorser may be needed, final decision will be made by the organizers of this campaign.



# Dr. Wen Ho Lee Revisited - What Happened According to Daughter Alberta Lee in 2000

On March 22, 2021, the Harvard Kennedy School's Institute of Politics posted a video titled <u>Alberta Lee: The Wen Ho Lee Story: What Happened?</u> on YouTube. Alberta Lee is the daughter of Dr. Wen Ho Lee. She spoke in a capacity auditorium in Harvard University on December 4, 2000, less than three months after Judge James Parker apologized to Dr. Lee and released him immediately from a courtroom in New Mexico. It is a rare and valuable video from a time before the term "webinar" and YouTube itself were even invented. It is unlikely many of you have seen it before.

From the video, there are lessons of racial profiling that will be familiar to many today. ### **Alert: New Requirement for Proposal Submission to DARPA**

DARPA stands for Defense Advanced Research Projects Agency. There has apparently been a new requirement for proposal submission to DARPA, as reflected in this solicitation (HR001121S0040: AMENDMENT 1), which says in part (page 24):

University or non-profit research institution performance under this solicitation may include efforts categorized as **fundamental research**. In addition to Government support for free and open scientific exchanges and dissemination of research results in a broad and unrestricted manner, the academic or non-profit research performer or recipient, regardless of tier, acknowledges that such research may have implications that are important to U.S. national interests and must be protected against foreign influence and exploitation. As such, the academic or non-profit research performer or recipient agrees to comply with the following requirements:

...

The academic or non-profit research performer or recipient must also utilize due diligence to identify Foreign Components or participation by Senior/Key Personnel in Foreign Government Talent Recruitment Programs and agree to share such information with the Government upon request.

. . .

i. The above described information will be provided to the Government as part of the proposal response to the solicitation and will be reviewed and assessed prior to award. Generally, this information will be included in the Research and Related Senior/Key Personnel Profile (Expanded) form (SF-424) required as part the proposer's submission through Grants.gov.

On September 20, 2021, DARPA also issued this Senior/Key Personnel Foreign Influence Risk Rubric or "risk levels" of Principal Investigators: <a href="https://bit.ly/2YPcFy1">https://bit.ly/2YPcFy1</a>. According to the Rubric, a key personnel is categorized as at least "Moderate Risk" for having some foreign ties (family, friends, professional, financial), some of which are with strategic competitors (i.e., Russia, China) or other countries with a history of targeting U.S. technologies for unauthorized transfer.

It is unclear at this time whether or when the DARPA requirements may apply to other federal funding agencies.
