On September 17, 2020, the House of Representatives passed H.Res. 908, a resolution condemning all forms of anti-Asian bigotry as related to COVID-19. The resolution, introduced by CAPAC First Vice Chair Rep. Grace Meng, is a response to the over 2,600 reported anti-Asian hate crimes and incidents in recent months which have been driven by misperceptions about the coronavirus and how it spreads.
